# Change of registry service provider

As part of our ongoing commitment to optimising our investor experience, from 14 November 2022 the unit registry services for the Fund will be managed by Automic Pty Ltd (**Automic**), replacing Link Market Services Limited.

This transition will result in a change to your existing unitholder account number and you will be issued with a new Investor Number. Depending on your communication preference, you will receive an email or letter from Automic notifying you of your new Investor Number.

### Benefits of the transition to Automic

One of the key benefits of this transition is that you will be able to manage your Ellerston Fund holdings via Automic's secure and accessible online Investor Portal. Existing investors will need to register for Automic's online Investor Portal by visiting <a href="https://investor.automic.com.au/#/signup">https://investor.automic.com.au/#/signup</a> and following these steps:

- 1. In the Company Name field, select "Ellerston Australian Micro Cap Fund Class A Units"
- 2. Enter your new Account Number
- 3. Enter your Postcode (or your Financial Advisers Postcode if they're linked to your account), or if outside of Australia, your Country of Residence
- 4. Tick the "I'm not a robot" box and click "Next"
- 5. Complete the prompts to set up your Username and Password

You will then have access to a single online interface to:

- Submit trade instructions such as additional applications and redemptions;
- Update and manage your details, including address and distribution preference;
- View performance, unit balances, and transaction history;
- Access all statements; and
- Renew your CRS-FATCA Self Certification.

Issue of new Product Disclosure Statement (PDS) and Additional Information to the PDS for the Fund

Please be advised that a new PDS and Additional Information to the PDS will be issued for the Fund. These documents will be dated and issued effective from 14 November 2022.

The new PDS will be updated with the following key changes:

# Updated Risk Level

We have adopted the Standard Risk Measure (SRM), which is an industry-wide risk measurement methodology. While the SRM is not a complete assessment of all forms of investment risk, it may help investors compare the risk of investment products. From 14 November 2022, the risk level of the Fund will change from <u>Medium to High</u> to <u>Very High</u>.

## Lower Minimum Investment Amount

From 14 November 2022, the minimum investment amount for the Fund will be lowered from \$25,000 to \$10,000.

The new PDS will be accessible on Ellerston's website (<u>www.ellerstoncapital.com</u>). If required, a printed version can be requested by calling Ellerston's Investor Relations team on (02) 90217701.

Please note, the new PDS dated 14 November 2022 replaces any previous copies of the PDS. Any Application Form(s) from the previous PDS dated 31 March 2021 will not be accepted from the issue date of the new PDS i.e. Application Forms from the previous PDS will not be accepted from 14 November 2022 onwards.
