Target Market Determination Ellerston Australian Share Fund



Introduction

This Target Market Determination (**TMD**) is required under section 994B of the *Corporations Act 2001*(Cth) (**the Act**). Target Market Summary

This product is intended for use as a satellite to minor allocation for a consumer who is seeking capital growth and has a high risk and return profile for that portion of their investment portfolio. It is likely to be consistent with the financial situation and needs of a consumer with a five-year investment timeframe and who is unlikely to need to withdraw their money on less than one week's notice.

Appropriateness

Investment products and diversification
