

1. Background to changes

Ellerston Capital advises that, effective immediately, Bill Pridham has resigned as Portfolio Manager of the Ellerston Global Mid Small Cap Fund.

Nick Markiewicz, currently Co-Portfolio Manager, will immediately assume the role of sole Portfolio Manager of the Fund.

2. Changes to PDS

In light of the changes described in section 1 above, the following updates are made to the PDS:

(a) In Section 2 About Ellerston Capital, on page 5 of the PDS, the paragraphs following the 'Key Personnel' heading are deleted and replaced with the following:

Nick Markiewicz as Portfolio Manager has overall responsibility for the Fund and devotes the majority of his time to the Fund. Nick is supported by a team of investment professionals, each of whom have significant skill and experience in different geographies, sectors and industries.

Nick joined Ellerston Capital in May 2024 and has over 13 years of industry experience.

Prior to Ellerston Capital, Nick was an Investment Manager at Lanyon Asset Management. Nick holds a Bachelor of Business (Hons), Economics from University of Technology, Sydney.
