Re: Issue of new Product Disclosure Statement (PDS) for Ellerston Global Mid Small Cap Fund — Class A Units (ARSN 609 725 868) (APIR Code: ECL8388AU) (Fund)

Please be advised that a new PDS will be issued for the Fund. These documents will be dated and issued effective from 30 September 2025. A summary of the key changes are outlined below:
