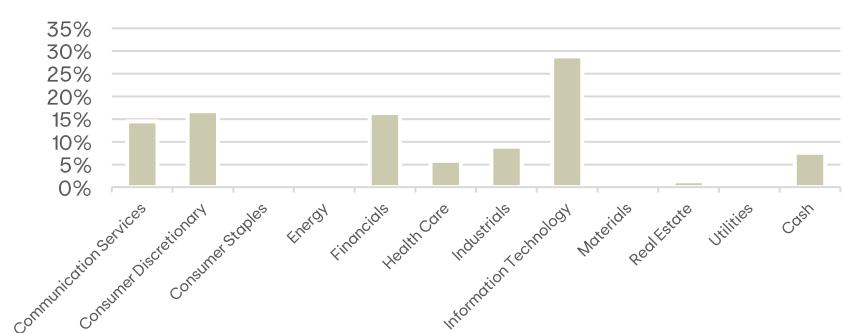

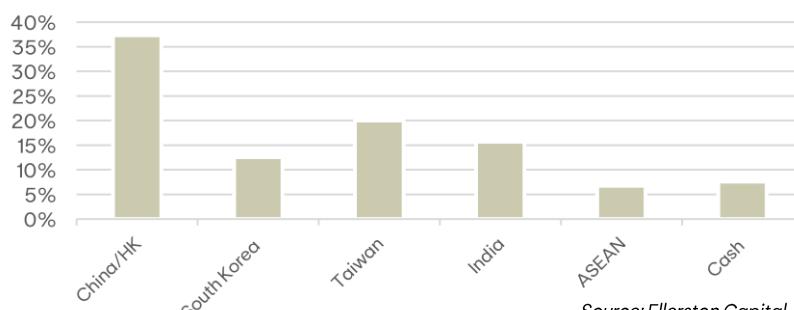

## PORTRFOIO COMMENTARY

The Ellerston Asia Growth Fund Complex ETF (The Fund) increased +0.8% in December, underperforming the MSCI Asia Ex-Japan (non-accumulation) Index (AUD) (The Benchmark) which increased +0.9%. The Fund delivered -0.3% in the December quarter, underperforming the Benchmark which was up +3.4%.

China will maintain economic support, but refrain from ramping up stimulus next year, according to an official readout from the Central Economic Work Conference. The leadership intends to "flexibly and efficiently" use interest rates and reserve requirement cuts to ensure sufficient liquidity and maintain a "necessary" level of budget deficit and government spending in 2026. Officials vowed to address several growth headwinds, including stemming the sharp slump in investment, steadyng the deteriorating housing market and stabilising dwindling new births. It appears China's leadership is giving itself plenty of room to be reactive to both internal conditions and external forces, largely the latter's impact on the strong economic track record of exports (helping to offset weak housing). Investors can expect to see larger deficits and more rate cuts. South Korea's KOSPI rallied by +7.3% in the month of December (led by foreign buying and its semiconductor stocks), the Taiwan market rose +4.8%, led by the optoelectronics sector, up +10.3%, while its semiconductor sector rose +9.4%. China's SSE followed +2.9%, supported by stronger than expected PMI data and Japan's Nikkei rose a more modest +0.3%. The Hang Seng and India's SENSEX, both of which fell -0.6%, were clear laggards in the Asian region.

China was the biggest relative detractor during the quarter, while Southeast Asia was the key outperformer. The portfolio faced headwinds in China and India as bullish sentiment faded and small/mid-cap stocks sold off sharply, against a backdrop of global liquidity tightening and a muted risk appetite amid ongoing geopolitical uncertainty. In hindsight, we misjudged the setup by positioning for more aggressive Fed cuts and easing US-China tensions, and our top three detractors, despite earnings upgrades and undemanding valuations, still suffered significant de-rating under the current market conditions.

## KEY QUARTERLY CONTRIBUTOR

**HD Hyundai Electric (601888 CN)**'s share price remained strong in the December quarter as investors continued to price in a multi-year power-equipment "super-cycle" supported by record order backlogs and rising

AI/data-centre and grid investment. The stock had already re-rated on earlier earnings surprises and a rapidly expanding high-voltage transformer backlog, which kept technical momentum and fund flows constructive into year-end despite broader Korean macro volatility. At the same time, more than half of its backlog and new orders coming from higher-margin overseas projects reinforced expectations of above-market earnings growth into 2026 and cemented the view that HD Hyundai Electric is a structural beneficiary of AI-driven power demand, grid renewal and electrification rather than a short-term cyclical trade.

## KEY QUARTERLY DETRCTOR

**China Ruyi** (136 HK)'s share price was weak in the December quarter as the stock digested earlier gains and equity placements, with sizeable year-end issuances and block trades weighing on sentiment and liquidity. Despite a solid earnings turnaround and strong growth in gaming and streaming, the name remained caught in a volatile China internet/entertainment complex, where macro concerns, policy noise, and weak southbound flows kept valuation and risk appetite capped. We remain constructive after meeting management in December, as the company is shifting from a volatile, low-margin film business toward a more recurring, high-margin gaming and platform model supported by Tencent, and we believe the current valuation of c.15x NTM EPS for roughly 20% earnings growth is undemanding and does not fully reflect the quality of its evolving earnings base or its balance sheet optionality.

## OUTLOOK

Going into 2026, we believe Asia is well positioned to outperform, supported by a weaker U.S. dollar, easing geopolitical and tariff risks, and still-light global investor positioning. We are particularly positive on four themes: (a) AI tech infrastructure, (b) cyclical industrials, (c) base metals such as copper and aluminium, and (d) continued corporate governance reform in Asia. We expect a significant capex cycle in the global semiconductor industry and progress in China's semiconductor sector to underpin tech optimism, while expansionary fiscal policies and data-centre build-outs should support industrials and base metals. Lastly, we expect large Asian corporates to continue improving governance and shareholder returns.
